WHAT HEALTH INFORMATION IS PROTECTED

We are committed to protecting the privacy of information we gather about you while providing health-related services. Some examples of protected health information include information about your health condition, genetic information, or information about your health care benefits under an insurance plan, each when combined with identifying information, such as your name, address, social security number or phone number.

However, please understand that information indicating that you are a client of our practice/program may be assumed by others 1. simply by your living in a group residential setting, participating in multi-family groups or your involvement in program and agency social and recreational activities.

REQUIREMENT FOR WRITTEN AUTHORIZATION

Generally, we will obtain your written authorization before using your health information or sharing it with others outside of our agency. There are certain situations where we must obtain your written authorization before using your health information or Payment. We may use your health information or share it with sharing it, including:

Marketing. We may not disclose any of your health information your health insurance company or state funder in order to obtain for marketing purposes if our agency will receive direct or reimbursement after we have treated you. In some cases, we may indirect financial remuneration not reasonably related to our share information about you with your health insurance company agency's cost of making the communication.

Sale of Protected Health Information. We will not sell your Health Care Operations. We may use your health information

HOW WE MAY USE AND DISCLOSE YOUR HEALTH INFORMATION WITHOUT YOUR WRITTEN AUTHORIZATION

There are some situations when we do not need your written authorization before using your health information or sharing it with others, including:

Treatment, Payment and Health Care Operations.

Treatment. We may share your health information with doctors or nurses at our agency who are involved in taking care of you, and they may in turn use that information to diagnose or treat you. A doctor in our agency may share your health information with another doctor to determine how to diagnose or treat you. Your doctor may also share your health information with another doctor to whom you have been referred for further health care.

If we do disclose your health information to a business associate, we will have a Law Enforcement. 5. **Emergencies or Public Need.**

Emergencies or As Required By Law. We may use or disclose your health information if you need emergency treatment or if we are required by law to treat you. We may use or disclose your health information if we are required by law to do so, and we will notify you of these uses and disclosures if notice is required by law.

Public Health Activities. We may disclose your health information to authorized public health officials (or a foreign government agency collaborating with such officials) so they may carry out their public health activities under law, such as Military And Veterans. If you are in the Armed Forces, we may controlling disease or public health hazards. We may also disclose your health information to a person who may have been command authorities for activities they deem necessary to carry exposed to a communicable disease or be at risk for contracting or spreading the disease if permitted by law. To Avert A Serious And Imminent Threat To Health Or Safety. We may use your health information or share it with others when necessary to prevent a serious and imminent threat to your health or safety, or the health or safety of another person or the public. In such cases, we will only share your information with someone able to help prevent the threat. We may also disclose your health information to law enforcement officers if you tell us that you participated in a violent crime that may have caused serious physical harm to another person (unless you admitted that fact while in counseling), or if we determine that you escaped from lawful custody (such as a prison or mental health institution).

National Security And Intelligence Activities Or Protective Services. We may disclose your health information to authorized federal officials who are conducting national security and intelligence activities or providing protective services to the President or other important officials.

YOUR RIGHTS TO ACCESS AND CONTROL YOUR **HEALTH INFORMATION**

You have the following rights to access and control your health

- Right To Inspect And Copy Records. You have the right to inspect and obtain a copy of any of your health information that may be used to make decisions about you and Coroners, Medical Examiners And Funeral Directors. In the your treatment for as long as we maintain this information in our records, including medical and billing records. To inspect or obtain a copy of your health information, please submit your information to funeral directors as necessary to carry out their request in writing to the Privacy Officer. If you request a copy of the information, we may charge a fee for the costs of copying, mailing or other supplies we use to fulfill your request.  - Right To An Accounting Of Disclosures. You have a right to request an "accounting of disclosures," which is a list with information about how we have shared your health information with others. To obtain a request form for an accounting of disclosures, please write to the Privacy Officer. You have a right to receive one list every 12-month period for free. However, we may charge you for the cost of providing any additional lists in
- Right to Receive Notification of a Breach. You have the right to be notified if there is a probable compromise of your Fundraising. We may use or disclose your demographic unsecured protected health information within sixty (60) days of the discovery of the breach. The notice will include a description of what happened, including the date, the type of information department of service information, treating physician, outcome involved in the breach, steps you should take to protect yourself from potential harm, a brief description of the investigation into the breach, mitigation of harm to you and protection against further breaches and contact procedures to answer your questions.
 - Right To Request Restrictions. You have the right to request that we further restrict the way we use and disclose your health information to treat your condition, collect payment for that Changes to this Notice. We reserve the right to change treatment, run our normal business operations or disclose information about you to family or friends involved in your care. You also have the right to request that your health information not be disclosed to a health plan if you have paid for the services in full, and the disclosure is not otherwise required by law. The

request for restriction will only be applicable to that particular service. You will have to request a restriction for each service thereafter. To request restrictions, please write to the Privacy Officer. We are not required to agree to your request for a restriction, and in some cases the restriction you request may not be permitted under law. However, if we do agree, we will be bound by our agreement unless the information is needed to provide you with emergency treatment or comply with the law. Once we have agreed to a restriction, you have the right to revoke the restriction at any time. Under some circumstances, we will also have the right to revoke the restriction as long as we notify you before doing so.

- 6. Right To Request Confidential Communications. You have the right to request that we contact you about your medical matters in a more confidential way, such as calling you at work instead of at home, by notifying the intake person who is assisting you. We will not ask you the reason for your request, and we will try to accommodate all reasonable requests.
- 7. Right To Have Someone Act On Your Behalf. You have the right to name a personal representative who may act on your behalf to control the privacy of your health information. Parents and guardians will generally have the right to control the privacy of health information about minors unless the minors are permitted by law to act on their own behalf.
- 8. Right To Obtain A Copy Of Notices. If you are receiving this notice electronically, you have the right to a paper copy of this notice. We may change our privacy practices from time to time. If we do, we will revise this notice and post any revised notice in our registration area and on our website
- 9. Right To File A Complaint. If you believe your privacy rights have been violated, you may file a complaint with us by calling the Privacy Officer at 978/538.0286, or with the Secretary of the Department of Health and Human Services. The practice will not withhold treatment or take action against you for filing a complaint.
- Use and Disclosures Where Special Protections May 10. Some kinds of information, such as HIV-related Apply. information, alcohol and substance abuse treatment information, mental health information, and genetic information, are considered so sensitive that state or federal laws provide special protections for them. Therefore, some parts of this general Notice of Privacy Practices may not apply to these types of information. If you have questions or concerns about the ways these types of information may be used or disclosed, please speak with your program director health care provider
